



ROY B. HERBERT TOP GUN 2015 MATCH  
PHILADELPHIA, PA.

The following course of fire shall be used for the 2015 event. This course shall be followed to the letter.  
All scores shall be posted after each shooter.

---

COURSE OF FIRE

Shall consist of **20-rounds** of ammunition (Two magazines 10-rounds each.) There will be **10 targets** that shall be engaged. Each target must be struck or knocked down before moving to the next target.

**There must be one (1) mandatory reload.**

Safety violations shall result in a One (1) point deduction. Clock shall start on the safety Officer's command. Clock will stop on the last target engagement.

---

STAGE 1 (25-yards)

Starting from a seated position in a patrol vehicle, the shooter shall engage two targets. Safely move to the second stage.

STAGE 2 (15-yards)

Shooter shall select a per loaded (magazine only) 12ga shotgun and engage two targets, safely secure the shotgun and move safely to the third stage.

STAGE 3 (10-yards)

From a kneeling position with a side arm engage two targets. Safely move to the fourth stage.

STAGE FOUR (7-yards)

While on the move, shooter shall engage two targets. (This shall be executed while moving. Stoppage in movement shall result in the lost of that target points) Shooter shall move to the fifth stage.

STAGE FIVE (5-yards)

From the standing position, the shooter shall engage two targets; afterwards the weapon shall be safely unloaded and secured in the holster. (Clock shall stop after the last target is engaged.)

Each Target is worth 10-points

**Shooter must receive a score of 75 to be rated for awards**
